Delays in Infrastructure (item requested by Cllr Haywood) 2501/28

> Cllr Haywood explained that it had been reported on the radio that the re-build of the hospital has been delayed by at least ten years, appointments are being cancelled due to a lack of beds and other operations are taking place at hospitals outside of the area and quite a way for the patients and visiting family members. Whilst Cllr Haywood understands we need more housing she did not feel that any further housing should be delivered until the lack of infrastructure is address.

> Members noted that the North Devon District Hospital is the most rural hospital in the area, and it is the only hospital on the list for rebuild that owns the land where the new hospital will be sited. It was further noted that the Government has increased the housing requirement for the area and in light of this change North Devon Council can no longer demonstrate a five-year housing land supply.

> After discussion it was resolved, with no votes to the contrary, for the Chairman of the Committee to write to the Secretary of State for Health & Social Care and the Secretary of State for Housing.

2501/29 **Street Naming and Numbering**

> Members considered the proposed name(s) for the new development: Glenwood View and Glenwood Business Park Roundswell members felt the proposed name of Glenwood View was too close to names of other developments in the area and it was resolved, with no votes to the contrary, to recommend Harvest Way.
